WITNESSETH, that in consideration of One and 00/100----- (\$1.00)-----

in hand paid, the receipt whereof is hereby acknowledged, the said grantor does hereby grant and convey to the said grantees, as TENANTS BY THE ENTIRETIES WITH THE RIGHT OF SURVIVORSHIP, their heirs and assigns,

ALL THAT CERTAIN tract of land situate in Greenwood Township, Juniata County, Pennsylvania, bounded and described as follows, to wit:

Herbert Miller. The said G. Herberg Miller a/k/a George Herbert Miller died testate March 20, 1981, having first made his Last Will and Testament which was properly probated March 25, 1981, in the Register of Wills Office of and for Juniata County and recorded in Will Book "O" at Page 411 in which the premises herein conveyed was devised to Emma L.
